How much money does Guinea Bissau import in 2022?

According to WTO, in 2022 the country imported USD 474 million worth of goods, exporting only USD 213 million (+15% and -29% year-on-year, respectively). In the same year, Guinea Bissau imported USD 157 million of services while its exports amounted to USD 33 million.

Where does Guinea Bissau export?

Guinea Bissau's exports are almost entirely directed towards India (92%), followed by Cote d'Ivoire (2.4%), Togo (2.2%), and the Netherlands (1.3%). Imports mainly come from Portugal (34%), Senegal (21.9%), China (14%), Netherlands (5.7%), and Spain (3.3%).

Does Guinea Bissau have a trade deficit?

Guinea Bissau's trade balance is structurally in deficit, and it worsened in recent years. According to WTO, in 2022 the country imported USD 474 million worth of goods, exporting only USD 213 million (+15% and -29% year-on-year, respectively).

Is Guinea Bissau a member of ECOWAS?

The country introduced a Common External Tariff (CET) in early 2000, in collaboration with other countries of the West African Economic and Monetary Union (WAEMU). Guinea Bissau is also a member of the Economic Community of West African States (ECOWAS).
